Physical Disability Handbook (shintai shougaisha techou)

This handbook is required for people with a physical disability to receive a variety of services. You must evaluated by a prefectural certified doctor and receive a certificate of your disabilities, after which you may apply for this handbook.

Rehabilitation Handbook (iryou techou)

Children with intellectual disabilities who wish to receive assistance must receive a Rehabilitation Handbook. If you qualify, you may receive a handbook after being evaluated at a prefectural consultation center or prefectural welfare center.

Intellectual Disability Handbook (seishin shougaisha hoken fukushi techou)

This handbook is required for people with an intellectual disability to receive a variety of services. You may apply to be evaluated at a prefectural mental health welfare center, and will receive this handbook if you qualify.

Welfare Services for Children with Disabilities

Visiting and Outpatient Services

Services for support at home and at social welfare facilities. There are benefits such as day service, short term admission, comprehensive support training for the severely disabled such as in-home care, visiting care for the severely disabled, action support, accompanying support, child development support, after school, etc.

Daytime Activity Services

There are services such as nursing care and training to support activities in the daytime at the facility. Nursing care benefits include medical care for persons with disabilities who need medical care and daily life care for persons who always need nursing care, and self-support training in the form of training and other benefits, etc.

Housing Support Services

There are nursing care benefits and benefits such as training at the place where you can't finish at the facility. Nursing care benefits include admission support in facilities and community life support in benefits such as training.

Delivery and Repair of Prosthetic Devices

Supplies and repairs of necessary prosthetic devices are provided to compensate for the physical disabilities of children and others and to facilitate daily life and life in the workplace.

Services and Supports for Persons with Disabilities (Medical Care for Rehabilitation, Medical Care for Raising Children, and Psychiatric Outpatient Care)

Medical Care for Rehabilitation

In principle, patients who undergo surgery to compensate for or reduce their disability receive 10% of their medical expenses.

Eligible Persons:

A person aged 18 or older with a physical disability certificate that is to receive medical treatment that is expected to have a definite therapeutic effect. (Examples of medical practice: cornea, joint formation, cardiac surgery, artificial dialysis, external ear formation, liver transplantation, etc.)

Medical Care for Raising Children

In principle, children with physical disabilities are able to receive 10% of their medical expenses at their own expense in order to provide them with the efficacy and functions necessary to receive treatment at an early stage and live in the future.

Eligible Persons:

A child under 18 years of age who falls under any of the following diseases and is expected to receive reliable treatment through surgery

(Subject diseases · · · Limb disability, vision, hearing, balance dysfunction, speech and language, masticatory dysfunction, kidney, heart, liver transplant, other visceral diseases, immune dysfunction due to HIV)

Psychiatric Outpatient Care

In principle, those who come to the hospital for psychiatric illness can receive 10% of their medical expenses.

Regional Daily Life Support

In order to more effectively support the lives of persons with disabilities and others in the region, the city takes the initiative in carrying out projects according to the actual conditions of the region. The city is engaged in the following businesses.

Business Name	Services
Consultation Support	In response to consultations from persons with disabilities, the Government will provide necessary information, support the use of welfare services for persons with disabilities, and support the protection of their rights.
Communication Support	Communication will be mediated and facilitated through methods such as sign language interpretation.
Equipment Services	Provide equipment for daily life.
Mobility Support	For persons with disabilities who have difficulty in moving outdoors, support will be provided to enable them to live independently in the community and participate in society when they go out.
Regional Activities Support Center	Providing opportunities for creative and productive activities and promoting interaction with society
Welfare Home	The Government will support the living of the community by providing housing equipped for the disabled with rent and other assistance.
Home Visit Bathing Service	Bathing service is provided by visiting mobile bathing vehicles for those who have difficulty bathing at home.
Rehabilitation Training Expenses	Rehabilitation training expenses shall be paid to persons using employment transfer support projects or self-reliance training projects, etc.
Temporary Daytime Assistance	When caregivers are unable to provide care due to emergency or ceremonial occasions, etc., support such as securing places for activities during the day and temporary supervision.
Promoting the Integration into Society	Promote participation in sports and recreation activities, training sign language volunteers, and promoting cultural and artistic activities.
